PRECINCT LIST OF VOTERS AND NUMBER OF BALLOTS

BALLOTS WITH APPLICATIONS

ENVELOPE 9 FOR TALLY SHEET AND BALLOTS

BAG # 4 FOR ALL DISCARDED APPLICATIONS AND ENVELOPES AND ANY REJECTED BALLOTS

1. COUNT YOUR BALLOTS AND COMPARE TO TOTAL ON TALLY SHEET
 - a. If they do not match, bring to my attention and we will give to the team working on problems
2. COMPARE SIGNATURES BETWEEN BALLOTS AND APPLICATIONS
 - a. Note – these may be electronic and may not match. Do not reject
 - b. Note – some nursing home residents may have assistance in signing or filling out ballot
3. PUT APPLICATIONS ASIDE AND SLIT OPEN THE ENVELOPES
4. PULL OUT BALLOT CARD FROM ENVELOPE AND SECURITY SLEEVE
5. CHECK BALLOT CARD ENCODING TO ENSURE THEY ARE CODED WITH THE CORRECT PRECINCT AND THEY HAVE AN ACTIVATION CODE ON THE FOURTH LINE. THESE INDICATE PARTY.
6. MARK ANY REJECTED BALLOTS WITH A RED PEN AND WRITE THE REASON ON THE BALLOT ENVELOPE
7. IF A CARD IS REJECTED, WRITE ON THE TALLY SHEET NEXT TO THE VOTER'S NAME – REJECTED
8. FILL OUT THE TALLY SHEET INDICATING ANY REJECTED CARDS AND PLACE THE NUMBER OF BALLOTS TO COUNT IN THE TOTAL COLUMN. INITIAL TALLY SHEET.
9. CARDS AND TALLY SHEET GO INTO ENVELOPE # 9
10. PLACE ALL REMAINING PAPERWORK INTO THE BAG # 4

REJECTION REASONS:

1. APPLICATION NOT SIGNED
2. BALLOT NOT SIGNED
3. APPLICATION AND BALLOT SIGNATURES ARE OBVIOUSLY SIGNED BY 2 DIFFERENT PEOPLE. SHOW TO INSPECTOR FOR 3RD OPINION
4. PLACE REJECTED BALLOT IN BAG #4 WITH A REASON CLEARLY MARKED ON THE ENVELOPE IN RED INK
5. DO NOT REJECT IF MISSING CLERK SEAL, CLERK INITIALS, SECRECY SLEEVE OR ANY MISTAKE THAT THE CLERK'S OFFICE MADE IN PREPARATION OF THE BALLOT
